**MANITOBA-BRED INCENTIVE PROGRAM**

**FOALS MUST BE CANADIAN REGISTERED.** Non-Manitoba residents foaling in Manitoba must have a veterinary certificate completed at the time of foaling and submit it with the Canadian Declaration to the CTHS National Office. Only foals by an accredited Manitoba sire qualify for breeder awards for non-Manitoba residents. **ONTARIO THOROUGHBRED IMPROVEMENT PROGRAM**

**FOALS MUST BE CANADIAN REGISTERED.** For the purposes of participation in the Ontario Thoroughbred Improvement Program, there will be the designation of a "Registered Ontario-Bred" foal from 2008 forward. To be eligible, the foal must be born out of an "Ontario Resident Mare". All Ontario foaled horses from 2007 and before have been "grandfathered" into this program.

**To be recognized by the Program as a 2009 Ontario Thoroughbred Resident Mare, a broodmare must foal out in Ontario during 2009 and must comply with one of the following criteria:**

1. Bred back to an Ontario Sire registered with the Ontario Sires Stakes Program in 2009;
2. Resident in the Province of Ontario by October 1, 2008;
3. Resident in the Province of Ontario for 150 consecutive days surrounding date of foaling out in Ontario;
4. Purchased (or an RNA – Reserve Not Attained) at a recognized sale or auction that operated in accordance with SITA (Society of International Thoroughbred Auctioneers) OR purchased privately in a bona fide arms length transaction, AND in either case, arrives within the boundaries of Ontario no later than 30 days after the date of purchase.

**IF registering a 2008 foal to the program,** please contact the office for the rules of eligibility

Notwithstanding the requirements above, by application to the Program, special considerations may be granted.

**Both sections of the Canadian Declaration form must be completed.** Documentation (invoices, export papers, etc.) may be requested of proof pursuant to the above criteria for the Program.
